



FLECK EX TOP

Universal stain remover





Ingredients:

FLECK EX TOP contains: less than 5% non-ionic surfactants, fragrance, 5-15% aliphatic hydrocarbon, linalool. Other ingredients: alcohol. pH-value: approx 7,5.

Performance:

FLECK-EX TOP removes quickly and easily solvent and water soluble stains from carpets, upholstery and textiles made of nature and synthetic fibres. It takes only a new minutes to be effective. The coated reverse side of a carpet does not soak.

Application notes:

For all natural and synthetic fibre for example carpets and textiles made of wool, cotton, viscose, silk, polyamide, polyacrylic, polyester, polypropylen etc. Suitable without problems for velours, loop pile and needle-fleece carpets.

Usage:

Removes stains as soon as possible. Check fastness of colour with FLECK-EX TOP and a white sponge on an inconspicuous area. Avoid soakness of the fibre therefore spray only with a few of FLECK-EX TOP or spray a sponge and dab the stain. In case of older or cough stains, leave FLECK-EX TOP to work a little bit longer. Dab FLECK-EX TOP with a white, clean, absorbent, non fraying sponge or paper. Do not rub, the stain may get bigger. Turn the sponge around or change it from time to time. Stains have to be treated from the outside to the inside. Afterwards, dab off remains of stains and FLECK-EX top with a water damp sponge. Brush up the moist pile, let it dry and do not walk on it. In case of very stubborn soiling, repeat the whole treatment. FLECK-EX TOP is also usable in combination with the shampoo and spray extraction method as well as cleaning with powder.

Precautions for use:

Highly flammable. Contains isopropylalcohol. Irritating to the eyes. Keep out of the reach of children. keep away from sources of ignition. Do not smoke. Only use in well-ventilated rooms. This material and/or its container must be disposed of as hazardous waste. Harmful to aquatic organisms, may cause long-term adverse effects in the aquatic environment. Vapours may cause drowsiness and dizziness.
